## **Results of Annual General Meeting**

SYDNEY Australia, 16 November 2023: Australian antiviral drug development company, Island Pharmaceuticals Ltd (ASX: ILA; "Island"; "the Company") advises that its Annual General Meeting was held today at 11.30 am AEDT.

The resolutions were voted in accordance with the Notice of Annual General Meeting previously advised to the Australian Securities Exchange.

Resolutions 2, 3, 4, 5 and 6 were passed on a poll, with Resolution 3 (Approval of increased placement capacity) and Resolution 4 (Adoption of new constitution) being passed by a sufficient majority as special resolutions.

Resolution 1 (Adoption of Remuneration Report) received a first strike.

#### **About Island Pharmaceuticals**

Island (ASX: ILA) is a drug repurposing company, focused on areas of unmet need for antiviral therapeutics to address infectious diseases. Our lead asset is ISLA-101, a drug with a well- established safety profile, being repurposed for the prevention and treatment of dengue<sup>2</sup> fever and other mosquito (or vector) borne diseases.

If ISLA-101 achieves FDA approval, and certain other criteria are met, Island may be eligible to obtain a "Priority Review Voucher" at the time of FDA approval. This means that as well as getting approval to manufacture and sell ISLA-101, the Priority Review Voucher (PRV) could permit Island to expedite the FDA approval process for a new drug or sell the PRV in a secondary market.
